TERMS AND CONDITIONS

1. The Show is conducted with the full status, regulations and by-laws of the Queensland Chamber of Agricultural Societies and shall be observed by exhibitors at all times
2. All stallholders shall have their exhibits set up no later than 8.00am on the first day of the Show.
 - a. **All stallholders must remain in the confines of space allocated.** Stallholders may service their stalls on the Saturday and Sunday mornings only if showing the **relevant entry permit.**
 - b. **ONLY VEHICLES WITH A RELEVANT ENTRY PERMIT WILL BE ALLOWED TO PARK ON THE GROUNDS AT ANY TIME. Failure to comply with this order will result in vehicles being towed away at the owner's expense.**
3. All stallholders serving food to the public, must comply with the "Food Hygiene Regulations" as set down by the Chief Health Surveyor, Moreton Bay Regional Council. Call 3205 0555 for any clarification.
4. The Society does not insure or otherwise guarantee the safety and security of any item of equipment or property of the stallholder.
5. The Society does not undertake to ensure the profitability of the stallholder's undertaking.
6. The Society reserves the right to refuse space without explanation at any time. The Society also reserves the right to have removed from the Showgrounds, any stallholder who puts the Society in disrepute.
7. **Stallholders must hold Public Liability Insurance, to the value of \$20,000,000.00 and must be attached to the application.**
8. **COVID Compliance Certificate must be attached to the application.**
9. Stall Holder Tickets:
 - a. Each stall will be supplied with 2 (Two) free stallholders passes.
 - b. If required, extra stallholders' passes are available at a cost of \$5.00 for the 3 days of the Show.
 - c. **Parking may be available at Pearson Park, Klingner Road at a cost of \$5.00 per day.**
10. **Applicants will be advised within 3 (Three) weeks of the commencement of the Show if space has been allocated.**
11. All stall holders must remain on the grounds for all **3 days** of the Show. Failure to do this will result in a full time ban for future shows. Advice of failure to comply will be forwarded to other Show Societies.
